**Consideration of Items Relating to Platting**

Mr. Agnelli stated that the purpose of this meeting is to authorize the Chairman to execute documents relative to platting for Phases 3A and 3F. Ms. Petruff stated that the first motion needed would be to authorize the Chairman to join in and ratify subdivision plats and all dedications and reservations thereon, and execute any documents which are prepared for this purpose.




**THIRD ORDER OF BUSINESS**
